ADVANTAGE INTRAVEL states, through the following, our firm commitment to privacy. This statement also describes INTRAVEL.ca's information gathering and dissemination practices. In summary, except as set forth below, ADVANTAGE INTRAVEL will not disclose or sell any of your personal information, including your name, address, credit card number, shopping, or transaction history, to any third party without your permission.

Cookies

Many Web sites, including INTRAVEL.ca, use cookie technology to help their customers navigate more efficiently. A cookie is a small text file of stored information that resides on your hard drive. From time to time, our site will request the cookie from your browser so that we can retrieve the stored information. This saves you from having to enter the same information or make the same selections over and over again. INTRAVEL.ca never uses cookies to store personal information, such as credit card numbers, nor can any Web site other than ours read the information we store in the cookie.

Please note that with most browsers, you can set the preferences to show a warning each time a cookie request is received. You can also set the browser not to accept cookies at all. However, for your convenience it is suggested that you allow your browser to accept cookies.

Reserve and Purchase

Our web site uses a reservation/request form allowing you to reserve and purchase travel services. We collect your contact information (like your email address), financial information (like you account or credit card numbers), and demographic information (like your postal code or age). We will share information about you and your purchase with the airline, hotel, car rental agency, cruiseline or other travel provider with whom you book travel. Customer Profiles

During the reservation process, you will also have the option of creating your customer profile. This information is maintained and updated by you. You may provide detailed or minimum information subject to what you are comfortable with. We use the information so that we can respond to your request as efficiently as possible and each time you return to our web site. It enables us to retrieve key details, such as your name, delivery information, general requests, credit card information, passport information, frequent traveler numbers and travel preferences, so you don't have to enter the same information each time that you make reservations on our system.

We use contact information from your customer profile or reservation form to forward confirmations. You may decline to receive mailings at any time; in order to decline, simply complete the section below. We use financial information provided by you to charge you for products and services purchased.
